Document Accessibility Training

In the Spring 2024 term, the Office of Digital Accessibility extended an invitation to those with document upload privileges on the Omni CMS to partake in a foundational Digital Document Accessibility Training course. This course offered participants the choice between group sessions lasting an hour or bespoke one-on-one training. Post-training, participants were required to undertake a 25-question Google Assessment, with the aim of achieving a score of 20 points or more, marking the successful completion of the course.

The objective of this training initiative is to ensure that all campus content editors not only complete the training but also pass it successfully. This commitment underscores our dedication to enhancing document accessibility across all campus websites. This beginner-level program provides content editors with the essential skills for creating accessible documents and guides them toward further comprehensive training resources. Ultimately, this initiative is a step towards fostering a more inclusive and accessible environment for all users.

DOJ (Department of Justice) Final Ruling

On April 8th, 2024, Attorney General Merrick B. Garland signed a final rule under Title II of the Americans with Disabilities Act (ADA) to ensure the accessibility of web content and mobile applications (apps) for people with disabilities. This final rule clarifies the obligations of state and local governments to make their websites and mobile applications accessible, ensuring equal access to online government services, including emergency information, courts, healthcare, schools, voting, and more. The rule specifies the Web Content Accessibility Guidelines (WCAG) 2.1, Levels A and AA, as the technical standard for accessibility.

How This Impacts CSU

As the CSU system receives federal and state funding, the Fresno State campus will comply with the new web rule. Our campus continues to work under the direction of the Chancellor's Office ATI (Accessible Technology Initiative) on the best next steps for this transition. Campus entities like the Office of IDEAS, Office of Digital Accessibility, the Web Office, and Procurement and Support Services are working under the leadership of the President's Office, the Office of the Provost, and the Chief Information Officer and Vice President for Information Technology to plan for the transition.

CSU-Fresno Preparing for Change

[The Office of Digital Accessibility is offering Digital Document Training](#) to promote document accessibility literacy and to aid in the final rule transition. The Office of IDEAS supports faculty with course content accessibility through live and asynchronous course content accessibility training, individual UDL (Universal Design for Learning) and accessibility consultations, document remediation help through the Academic Technology Resource Center, and additional online resources.
